- 一、適用對象:113 學年度起入學之跨院國際博士班學位學程人文組博士班研究生適用。
- 二、修業規定:
  - (一)修業年限:二年至七年。
  - (二)修業規定:
    - 1. 學生應修滿 24 學分; 逕讀博士者,進入本學程後應修滿 30 學分。
    - 主要為中文授課,部分人文社會領域之英語課程可計入,須經指導 教授同意。
    - 3. 論文研究學分另計。
  - (三) 畢業門檻:
    - 1. 完成修課規定、資格考試及通過畢業論文口試與規定。
    - 2. 海外經歷要求:至少一個學期的海外實習、國外修課、交換學生、海外相關領域之工作經驗。出國機會可能由指導教授/本學程或學生自行安排,皆採自費方式。入學前即已具備上述經歷者可經由指導教授同意後申請抵免。外籍生、僑生、陸生可免海外經歷。
    - 3. 外語要求:限五年內之成績。本國生、陸生、港澳地區僑生,須通過托福(iBT 80)、多益(750)、雅思(6.5)、其他經學程辦公室認可之英文能力證明,或通過「教育部對外華語教學能力認證考試外語能力 合格認定基準」中,其中一個非英文之外語標準。外國學生、非港 澳地區僑生,須通過 TOCFL 聽力、閱讀測驗 C1(流利)級以上之標 準。
    - 4. 教學實習要求:修讀華語教學領域者,教學實習至少100小時。入 學前即已具備正規華語教學經歷並獨立授課超過100小時可申請抵免 (不含一對一輔導)。
    - 論文發表:一篇在漢學或華語教學領域之研究期刊論文,或經匿名 審查之專書論文,並且為主要作者。

- 6. 資格審查:在論文發表之外,指導教授亦將以研究內容之品質、對該領域之影響力與實用性作為學生畢業與否之評核標準,避免僅以論文篇數作為畢業與否之單一規定。
- 7. 資格考試:學生需於修業第三學年內,完成資格考試。資格考試分 兩階段進行:
  - (a)學程初審:考生於資格考口試四週前繳交論文計畫書至學程辦 公室,由學程主任召集本校專任教師擔任審查小組,小組成 員至少三名。審查方式得以書面或口試方式進行,通過後始 得辦理資格考口試。
  - (b) 資格考試:採公開口試方式進行,校內、外口試委員(含指導 教授)至少三名,口試內容及論文計畫書內容,以論文研究方向 為主。口試不及格者,需於次學期結束前再次申請辦理。重考 以一次為限,不及格者應即退學。
- 8. 畢業論文及口試
  - (a) 本學程學生欲申請博士論文口試,應滿足下列規定:
    - (i) 通過博士班研究生資格考試至少六個月以上。
    - (ii) 滿足論文發表規定。
    - (iii) 满足外語能力要求。
    - (iv) 满足海外經歷要求。
    - (v) 繳交論文初稿至學程辦公室。
  - (b) 畢業論文口試之申請,應於口試前六週提出。
  - (c) 申請論文口試時應提出之申請文件如下所列:
    - (i) 經指導教授與申請人簽名之論文口試申請表。
    - (ii) 博士班成績單。
    - (iii) 博士論文初稿。
    - (iv)刊登於學術期刊之論文抽印本或論文被學術期刊接受之證明文件與論文稿。
    - (v)博士班研究生論文口試考試委員推薦書。
    - (vi) 論文相似度比對報告,比對比例應低於25%為原則。
  - (d) 論文口試前須進行學程初審程序,由學程主任召集本校專任教師擔任審查小組,小組成員至少三位。審查方式以口試方式進行,通過後始得辦理論文口試。
  - (e) 論文口試由考試委員會主持,採公開方式進行。考試委員會之 成員由指導教授推薦組成。
  - (f) 學位考試委員資格:

- (i) 助理教授及助理研究員職級以上者。
- (ii) 取得博士學位 3 年(含)以上之專家學者。
- (g) 口試不及格者,得於次學期或次學年重考,重考以一次為限, 不及格者應即退學。
- (h) 各階段考試結果均應向學程辦公室及學程主任報備。
- 三、學位授予:於修業年限內完成學程修業規定,授予指導教授所屬之學院博士學 位。本學程研究生得申請修讀合作學校的雙聯學位,修業依兩校MOU規定辦 理。
- 四、學雜費及獎助學金
  - (一)學雜費收費基準:本地生及外國學生採一致收費標準,皆依本校博士 班外國學生(理工領域)收費標準收取學雜費基數;另依每學期所修 學分數收取學分費,每學分新臺幣 5,000 元。
  - (二) 獎助學金: 校方將視經費狀況酌予核發獎助學金。
- 五、其他
  - (一)博士生修業年限為二至七年,在職生得延長修業年限二年。
  - (二)入學後一個月必需選定指導教授,向學程辦公室登記,繳交指導教授同意書。選課須由指導教授簽名,第二學期開始,學程主任不得代為簽名。
  - (三) 其他未訂事項,悉依國立清華大學教務章則規定辦理。

## Information and Degree Requirements for the Division of Humanities, IPhD (International Intercollegiate Ph.D. Program)

Confirmed and Approved by IPhD council on June 22nd, 2017 Confirmed and Approved by IPhD council on September 23rd, 2019 Confirmed and Approved by IPhD council on May 6th, 2021 Confirmed and Approved by IPhD council on March 24th, 2022 Confirmed and Approved by IPhD council on March 1st, 2023 Confirmed and Approved by IPhD council on December 21st, 2023

I. Eligibility : Applicable to IPhD students enrolling after the academic year of 2024.

- II. Degree Regulations for IPhD students
  - i. Period of Ph.D. study : 2 to 7 years.
  - ii. Course Requirements:

For degree requirements, complete a minimum of 24 credits of approved course work; For direct doctoral students, complete a minimum of 30 credits upon enrollment of IPhD program.
 Most of the courses are taught in Chinese. Courses in English may be counted but should be

approved by advisor.

3. Registered dissertation credits are extra and not included in the minimum 24 credits.

- iii. Graduation Requirements:
  - 1. Completion of course requirements, qualifying exam, oral defense, and dissertation.
  - 2. Overseas experience requirement:

A minimum one semester of overseas practicum, internship, student exchange or working for the related fields is required before graduation. Opportunities of going abroad may be arranged by the advisor/program or students themselves.

The overseas expenses is on the self-paid base. The requirement can be waived based on advisor's approval if students have own the equivalent overseas experience prior to the study. Foreign students, overseas Chinese students, and Mainland Chinese students are eligible for exemption from the graduation requirement of overseas experience.

3. Foreign Language requirement:

Scores obtained within the past five years are accepted. Local students, Mainland Chinese students, Hong Kong, and Macau overseas Chinese students must provide English proficiency certification through TOEFL (iBT 80), TOEIC (750), IELTS (6.5), or other English proficiency tests recognized by the IPHD office. Alternatively, they may meet the foreign language proficiency requirements by passing one of the non-English foreign language standards specified in the "Foreign Language Proficiency Standards for the Certification Examination for Proficiency in Teaching Chinese as a Second/Foreign Language (MOE)." Foreign students and non-Hong Kong and non-Macau overseas Chinese students must pass the TOCFL Listening and Reading Test at the C1 (Level 5) level or above.

4. Teaching Internship Requirement: Students in the field of Chinese language teaching are required to complete a teaching internship of at least 100 hours. Those who have already obtained formal Chinese language teaching experience and have independently taught for more

than 100 hours before enrollment may apply for exemption (excluding one-on-one tutoring).

5. Publications:

A minimum of one publication or refereed book chapter in the fields of Sinology/Chinese Studies or Teaching Chinese as a Second Language as the main author.

- 6. Qualification Approval: in addition to the publication paper number, the student's qualification for IPhD degree will also evaluated by advisor based on the quality, impact and academic/practical contribution of student's research.
- 7. Qualifying Exam: students must pass the oral qualifying exam before the end of the third academic year. The qualifying exam will be implemented in a two-stage process.
  - (a) Preliminary review: Prior to the exam, the student must submit a written form of "proposal" to IPhD office no later than 4 weeks before the oral exam. The dean of IPhD and 2 NTHU full-time professors serve as the committee to review the qualifying proposal. There should be at least 3 committee members in the committee. The preliminary review can be held in written or oral. Student may take the qualifying oral exam after passing the preliminary review.
  - (b) Qualifying exam should be held by the committee and is open to public. Committee members are recommended and formed by the student's advisor. There should be at least 3 professors (including the advisor) on or off campus to form the committee. The contents of oral exam and proposal should be consistent with the candidate's ongoing dissertation research. Fail to pass the oral exam should re-take the oral exam by the end of the next semester. Re-take oral exam is limited to one time. Failure for the second time should be dismissed form the program and the university.
- 8. Thesis Dissertation and Oral Defense Examination:
  - (a) Prior to applying for the oral defense, student should complete the following requirements:
    - (1) Pass the qualifying exam for at least 6 months.
    - (2) Satisfy with the publication requirement.
    - (3) Satisfy with the overseas experience requirement.
    - (4) Satisfy with the foreign language requirement.
    - (5) Complete dissertation draft and submit it to IPhD office.
  - (b) Application for oral defense examination should be set forth to program office 6 weeks before the examination is held.
  - (c) The following supplemental documents must be submitted alone with the oral defense application form to program office:
    - (1) Application form for oral defense exam.
    - (2) Official transcript for all Ph.D. studies.
    - (3) Dissertation draft.
    - (4) The hardcopy of publication in published journal format.(If the paper had not been formally published, the proof of acceptance is required to be turned in besides paper hardcopy.)
    - (5) Defense committee form with all committee member lists.
    - (6) The Similarity Reports of Thesis (Plagiarism Detection). The proportion of a thesis similarity report should be less than 25% as a guideline.
  - (d) Preliminary review should be held prior to the oral examination. The dean of IPhD and 2 full-time professors serve as the review team. The team should be consisted of at least 3

professors. Review should be held orally. Dissertation qualifying exam should be taken after passing the oral examination.

- (e) Oral defense exam is hold publically by the committee. Committee members are recommended and formed by the advisor.
- (f) Qualification for the committee members:
  - (1) Assistant professor or Assistant researcher (or higher rank).
  - (2) Experts or professional scholars who received a doctorate at least three years.
- (g) Each Ph.D. candidate could only retake defense exam once either next semester or next academic year if he/she failed the first time. Failure to defense exam will result in being suspended from IPhD program.
- (h) The results for qualifying exam and oral defense exam should be reported to IPhD program office.
- III. Doctor of Philosophy (Ph.D. degree): The Ph.D. degree is administered by the college which the student's advisor is affiliated with. Each IPhD student must fulfill all the degree requirements and regulations to get the Ph.D. degree. IPhD student s are eligible to apply for dual-degree program according to the dual-degree program MOU.
- IV. Tuition, fees and scholarship:
  - i. Tuition and fees: the rate is the same as regular students for both domestic and international students according to the university policy.
  - ii. Scholarships: maybe applied. The budget depends upon the university budget status.

V. Notes

- i. The period of Ph.D. study is 2 to 7 years. Part-time study may be extended up to 9 years.
- ii. The "Advisor Confirm Form" should be submitted to the office within one month after enrollment. Each student should have the advisor's approval for courses selection except the 1st semester. The IPhD program Chairman could not approve the courses registration after the 1st semester.
- iii.Students should refer to the "Academic Regulations" of National Tsing Hua University for the regulations not shown in this bulletin.
